In 2023, the Maine Department of Health and Human Services' Office of Aging and Disability Services awarded grants of up to \$500,000 to 19 programs to support development of innovation pilot projects in the state of Maine in alignment with Home and Community Based Services (HCBS) goals.

  - Where possible, describe opportunities for waiver participants from Maine be a part of the presentation
  - Describe how the proposed talk aligns with Lifespan policy objectives
  - Presentation type (if a panel, must limit to a maximum of four (4) panelists and the moderator and panelist info should be included in the proposal)
  - Topic theme(s)
  - Target audiences
  - Top 3 attendee take-aways
  - CEU information (if applicable)
  - Goal of the session
  - Speaker credentials (including CV, headshot and introduction bio)
- 4. Speaker Selection Criteria: The content team will make selections considering the following criteria:
  - Alignment with the policy objectives of the proposed Lifespan waiver (Details found at <u>HCBS</u> <u>Lifespan Project | Department of Health and Human Services (maine.gov)</u>)
  - Concise objectives
  - Actionable takeaways for attendees
  - A unique take on the latest trends in Disability Services that will inspire and educate
  - A diverse voice and point of view
  - Shows engagement, mobilization and enthusiasm on the topic
  - Higher weight/preference will be given for presentations that include states or providers that have used a tool and can give concrete examples; OR family members or others who have used technology and can provide experience

- Program finalized: mid-January, 2025
- Registration opens: mid-January 2025
